2018 OHV PROGRAM PRIORITIES

- + Public education and/or outreach to increase registration and showcase the benefit of OHV communities.
- + Projects that move public lands in Nevada towards having travel plans completed and will result in trail mapping and creation of maps for the public.
- + Preservation of Access.
- + New facility and program development: restrooms, trails, signs, and other amenities in areas with proven demand.
- + Connectivity between trails, facilities and other locations.
- + Environmental studies, projects and programs that will result in maintaining or expanding OHV riding areas.
- + Projects that consider water and habitat conservation. Trail features that are designed to be sustainable while protecting environmentally sensitive areas or important wildlife habitat.
- + Maintenance and/or rehabilitation of existing facilities. "Taking care of what is already there to protect the investment."
- + Partnership initiatives.

WHY SHOULD I REGISTER MY OFF-HIGHWAY VEHICLE?

- 1 FUNDS IMPROVEMENTS
- 2 KEEPS DOLLARS IN NEVADA
- 3 IT'S THE LAW

REGISTRATION IS EASY!

**STEP ONE
SELECT THE APPROPRIATE FORM**
Registration forms and procedures differ depending on when and where your vehicle was purchased or whether it is homemade. A separate form is needed for each vehicle.

**STEP TWO
TAKE APPROPRIATE FORM AND VEHICLE FOR A VIN INSPECTION**
A Vehicle Identification Number (VIN) inspection will have to be completed by a licensed Nevada Off-Highway Vehicle dealer or a sworn law enforcement officer if your vehicle has never been registered or titled in Nevada.

PLEASE NOTE: The DMV does not perform VIN inspections for Off-Highway Vehicles.


**STEP THREE
COMPLETE APPLICATION AND MAIL IN SUPPORTING DOCUMENTATION**
The dealer who completes the inspection may submit the application and other documents on your behalf or you may mail them yourself. Dealers may charge up to \$2 for each registration and/or title application submitted.

The Nevada Certificate of Title, if issued, is processed separately from the registration decal. All ownership documents will be required to title the Off-Highway Vehicle. The title will be mailed to the lender or other lienholder, if any, or to the owner if there is no lienholder.


PLEASE NOTE:
When you receive your registration decal, affix the decal to the Off-Highway Vehicle. Decals are issued by mail only.
Once you've registered for the first time, renewal can be done online or by mail.

GRANT PROGRAM

The Nevada Off-Highway Vehicle Program promotes safe and responsible use of Nevada's outstanding opportunities for motorized recreation. Any person or group is eligible to apply for a grant.

EXAMPLES OF MOTORIZED PROJECTS:

- + Trail planning and environmental studies
- + Partnership initiatives
- + Easement and land acquisition for trail access
- + Construction, maintenance, and restoration of trails and facilities
- + Trail tools and equipment
- + Restoration and rehabilitation of areas that have been damaged by OHV use
- + Trailheads, signs, kiosks, parking, campgrounds and other OHV facilities
- + Programs and projects promoting OHV trail ethics, safety and education
- + Registration events and enforcement
